10. Description and Purpose of Organization (Limit length to visible area)

The Hampden Family Center is a community-based provider of programs and services to alleviate the effects of poverty in our community. Services include: After-school and summer enrichment and tutoring programs, Adult Basic Education and GED preparation classes, exercise classes and nutritious meals for seniors, health fairs, free flu shots; preventative health screenings and programs, and assistance with connecting families to public benefits including food stamps, utility assistance and WIC (Women, Infants, and Children) are some of the programs Hamden residents rely on. Our outreach efforts for children include distributing free backpacks with school supplies, Thanksgiving and Easter baskets, winter coats, toys distributed during the holidays, and a community party during the winter holiday. In total, we served just over 2,000 individuals in FY16.

11. Description and Purpose of Project (Limit length to visible area)

The Hampden Family Center's renovations will improve the facility, maximize space, enhance and expand program offerings and grow our capacity as a service provider for Hampden's low income community. Improvements include: 1. ADA compliance with the installation of the an elevator for movement between three floors, and a ramp for wheelchair access. 2. Handicap accessible restrooms on each floor. 3. Installation of a water sprinkler system to improve public safety. 4. Upgrades to mechanical and plumbing systems, and to HVAC for energy conservation and reduced operating overhead. 5. Redesigned meeting spaces and expanded classrooms, including widened doorways for accessibility, for expanded capacity and greater privacy with soundproofing. 6. Enhanced technology capacity for key programs, including adult literacy, GED preparation, workforce development and job training.

28. Comments

Hampden is home to 8,600 low-income individuals of which only 28% of them have earned a high school diploma. Most are qualified only for entry-level employment or minimum wage jobs. Over 48% of Hampden households earn less than \$25,000 a year. A 20% unemployment rate impacts children's health and development as well as the security of their families.

The Hampden Family Center is an anchor institution of the Hampden community, the only resource for residents requiring human, social and educational services. It serves 2,000 people annually.

FY15 & FY16 service accomplishments include:

- 1, After school and summer enrichment programs served 120 children in 1st 5th grades.
- 2. Approximately 90 students enrolled in our Adult Basic Education (ABE) and GED preparation

classes, which are led quarterly by Strong City Baltimore.

- 3. More than 350 seniors attended our monthly senior luncheon, where they are given a free and
 - nutritious meal with the opportunity to socialize.
- 4. Over 400 neighborhood residents attended our annual health fair, where they received free flu

shots, preventative health screenings, and medical resources.

5. Outreach efforts for children and families included the distribution of over 150 free backpacks with school supplies; 250 Thanksgiving and Easter baskets; 200 winter coats; and

Christmas gifts to more than 300 families with young children.

The Hampden Family Centers newly \$1.6 million renovated facility to open in spring 2017 is redesigned to maximize its 7,646-sq. ft. of space for program expansion. Our highest priority is to make the Family Center a more effective and innovative community service provider. The following is just a sample of expanded and new programming opportunities.

1. The children's new larger area is a safe, fun, and educationally stimulating section allowing us

to expand enrollment from 30 in one session to at least 45 children.

2. Meeting spaces and classrooms for preventative health programming, tutoring, case management of Maryland Energy Assistance Program (MEAP), WIC, and Supplemental

Nutrition Assistance Program (SNAP) and associated benefit programs give greater privacy for

personal counseling.

3. An up-to-date technology center strengthens programs for GED preparation, job training
