## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and K. Young" and substitute "<u>K. Young, Hill, Krebs, Metzgar, Morales, Morgan, Pendergrass, Platt, Saab, and Szeliga</u>"; in line 3, strike "Medical"; in line 4, strike "an" and substitute "<u>a certain</u>"; in the same line, strike "submit certain evidence" and substitute "<u>attest on a certain registration form</u>"; in lines 6 and 8, in each instance, strike "medical"; in line 7, after "Department" insert "<u>or renew a certain registration</u>"; in line 8, after "the" insert "<u>prescribing or</u>"; in line 9, strike "developed by organizations" and substitute "<u>recognized by a certain licensing or certification board or</u>"; strike beginning with "requiring" in line 10 down through "Department;" in line 12; and in line 17, strike "and 5–302".

### AMENDMENT NO. 2

On page 2, strike beginning with "BEFORE" in line 8 down through "AN" in line 9 and substitute "AN"; in line 10, after "PROVIDER" insert "APPLYING FOR A REGISTRATION TO DISPENSE A CONTROLLED DANGEROUS SUBSTANCE UNDER THIS SECTION AND WHO WILL PRESCRIBE OR DISPENSE CONTROLLED DANGEROUS SUBSTANCES UNDER THAT REGISTRATION"; in the same line, strike "SUBMIT" and substitute "ATTEST ON THE REGISTRATION FORM"; strike beginning with "SATISFACTORY" in line 10 down through "MEDICAL" in line 12 and substitute "THAT THE AUTHORIZED PROVIDER HAS COMPLETED 2 HOURS OF CONTINUING"; after line 12, insert:

# "(2) AN AUTHORIZED PROVIDER SHALL MAKE THE ATTESTATION REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION:

- (I) <u>BEFORE THE AUTHORIZED PROVIDER'S INITIAL</u>
  REGISTRATION; OR
- (II) IF THE AUTHORIZED PROVIDER IS REGISTERED BEFORE
  OCTOBER 1, 2018, BEFORE THE FIRST RENEWAL OF THE AUTHORIZED
  PROVIDER'S REGISTRATION THAT OCCURS ON OR AFTER OCTOBER 1, 2018.";

in line 13, strike "(2)" and substitute "(3)"; in the same line, strike "MEDICAL"; in line 15, after "THE" insert "PRESCRIBING OR"; and in line 17, strike "DEVELOPED BY ORGANIZATIONS THAT ARE" and substitute "RECOGNIZED BY THE AUTHORIZED PROVIDER'S LICENSING OR CERTIFICATION BOARD OR".

On page 3, strike in their entirety lines 6 through 20, inclusive.
