CHAPTER _____

1 AN ACT concerning

2 **Criminal Law – Hate Crimes – Group Victim**

3 FOR the purpose of prohibiting a person from committing certain acts against a group
4 because of the group's race, color, religious beliefs, sexual orientation, gender,
5 disability, or national origin, or because the group is homeless; and generally relating
6 to hate crimes.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Criminal Law**

15 10–304.

17 beliefs, sexual orientation, gender, disability, or national origin, or because another

1 **PERSON OR GROUP** is homeless, a person may not:

2 (1) (i) commit a crime or attempt to commit a crime against that person
3 **OR GROUP**;

4 (ii) damage the real or personal property of that person **OR GROUP**;

5 (iii) deface, damage, or destroy, or attempt to deface, damage, or
6 destroy the real or personal property of that person **OR GROUP**; or

7 (iv) burn or attempt to burn an object on the real or personal property
8 of that person **OR GROUP**; or

9 (2) commit a violation of item (1) of this section that:

10 (i) except as provided in item (ii) of this item, involves a separate
11 crime that is a felony; or

12 (ii) results in the death of [the] A victim.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2018.
