AN ACT concerning
Transportation - Highway User Revenues - Distribution
FOR the purpose of altering the percentages of amounts of and process for appropriating highway user revenues funds that are required to be distributed to Baltimore City, counties, and municipalities in certain fiscal years; requiring that certain capital highway grants may be made only under certain circumstances; altering the percentages in requiring that in certain fiscal years of highway user revenues that are required to be used as authorized under the Transportation Trust Fund; repealing certain obsolete distributions and transfers of highway user revenues for
