Agriculture – Nuisance Insects

FOR the purpose of authorizing the Secretary of Agriculture to implement, under certain circumstances, a program to use a certain pesticide to control or eliminate nuisance insects in the State; requiring the program to be implemented on certain property; authorizing specifying that a certain notice be provided to certain entities and posted on certain social media sites; authorizing the Secretary to carry out a certain project to control or eliminate nuisance insects if the county or municipality in which the nuisance insects are located agrees to pay a certain portion of certain costs; establishing the Nuisance Insects Fund as a special, nonlapsing fund; requiring the Secretary to remit certain payments to the Comptroller for deposit to the Fund; requiring the Secretary or the Secretary's designee to administer the Fund; specifying the contents of the Fund; specifying the purpose for which the Fund may be used; repealing certain provisions of law relating to black fly management and
