House Bill 172

(Chair, Ways and Means Committee)(By Request -

Ways and Means

Education, Health, and Environmental Affairs

Election Law – Voter Registration Deadlines

This departmental bill alters the time of day, on the twenty-first day preceding an election, at which voter registration closes. Instead of closing at 9 p.m. on the twenty-first day preceding an election, voter registration closes at (1) 5 p.m. for applications and changes to voter registration records submitted by a method other than through the State Board of Elections' (SBE) online voter registration system and (2) 11:59 p.m. for applications and changes to voter registration records submitted through SBE's online voter registration system. The bill correspondingly repeals requirements that SBE and the local boards of elections remain open until 9 p.m. on the day of the close of voter registration prior to each election.

Fiscal Summary

State Effect: General fund expenditures decrease minimally each fiscal year, beginning in FY 2020. Revenues are not affected.

Local Effect: Local government expenditures decrease minimally each fiscal year, beginning in FY 2020. Revenues are not affected.

Small Business Effect: SBE has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment. (The attached assessment does not reflect amendments to the bill.)

Analysis

Current Law: With the exception of voter registration during early voting, voter registration is closed beginning at 9 p.m. on the twenty-first day preceding an election until the eleventh day after that election. The State and local boards of elections must remain open until 9 p.m. on the day of the close of voter registration prior to each election.

State and Local Fiscal Effect: General fund and local government expenditures decrease minimally each fiscal year, beginning in fiscal 2020, due to savings in personnel and other costs as a result of the deadline for voter registration by methods other than online registration being moved from 9 p.m. to 5 p.m.
