- (b) The list provided under this section shall:
 - (1) Be provided free of charge; and
 - (2) Include, for each person on the list:
 - (i) The name and mailing address of the person; and

(ii) <u>1.</u> The federal tax identification number of the person, [or,] if KNOWN; OR

2. IF the person does not have a federal tax identification number, the Social Security number of the person, IF KNOWN.";

strike beginning with "(A)" in line 18 down through "(B)" in line 23; strike beginning with "DENY" in line 23 down through "REQUIREMENTS" in line 26 and substitute "<u>REQUIRE AS A CONDITION</u>"; and in line 26, after "REGISTRATION" insert "<u>THAT AN</u> <u>APPLICANT:</u>

(1) PROVIDE PROOF THAT THE APPLICANT IS LAWFULLY PRESENT IN THE UNITED STATES, AS ALLOWED UNDER 8 U.S.C § 1621; OR

(2) HAVE A SOCIAL SECURITY NUMBER OR INDIVIDUAL TAXPAYER IDENTIFICATION NUMBER".
