Talbot County - Speed Monitoring Systems - Intersection of Maryland Route
333 (Oxford Road) and Bonfield Avenue

- 4 FOR the purpose of authorizing the placement and use of a speed monitoring system at the 5 intersection of Maryland Route 333 (Oxford Road) and Bonfield Avenue in Talbot 6 County, subject to placement and signage requirements; requiring the fines collected 7 by the Town of Oxford as a result of violations enforced by a speed monitoring system 8 to be used to assist in covering the cost of roadway and pedestrian safety 9 improvements in and around the intersection of Maryland Route 333 (Oxford Road) 10 and Bonfield Avenue; requiring a certain real-time display of a driver's traveling 11 speed for a speed monitoring system operating at the intersection of Maryland Route 12 333 (Oxford Road) and Bonfield Avenue; and generally relating to the placement and 13 use of a speed monitoring system in Talbot County.

- 1 places a mobile or stationary speed monitoring system to or at a location where a speed 2monitoring system had not previously been moved or placed, the local jurisdiction may not 3 issue a citation for a violation recorded by that speed monitoring system: 4 1. speed monitoring system is in use is proximate to a device that displays a real-time posting of the speed at which a driver is traveling.

- (c) (1) Unless the driver of the motor vehicle received a citation from a police officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is recorded by a speed monitoring system while being operated in violation of this subtitle.
- 7 (2) A civil penalty under this subsection may not exceed \$40.
- 8 (3) For purposes of this section, the District Court shall prescribe:
- 9 (i) A uniform citation form consistent with subsection (d)(1) of this 10 section and § 7–302 of the Courts Article; and
- 11 (ii) A civil penalty, which shall be indicated on the citation, to be paid 12 by persons who choose to prepay the civil penalty without appearing in District Court.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023. It shall remain effective for a period of 5 years and, at the end of September 30, 2028, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
