SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Family Law

~~(a) (1) Except as provided in subsection (b) of this section, in any custody or visitation proceeding the court may include as a condition of a custody or visitation order a requirement that either party provide advance written notice of at least 90 days to the court, the other party, or both, of the intent to:~~

~~(I) relocate the permanent residence of the party or the child either within or outside the State; OR~~

~~(II) TRAVEL OUTSIDE THE UNITED STATES WITH THE CHILD.~~

~~(2) The court may prescribe the form and content of the notice requirement.~~

~~(3) If the court orders that notice be given to the other party, a mailing of the notice by certified mail, return receipt requested, to the last known address of the other party shall be deemed sufficient to comply with the notice requirement.~~

~~(4) If either party files a petition regarding a proposed relocation OR INTENT TO TRAVEL within 20 days of the written notice of the relocation OR TRAVEL required by paragraph (1) of this subsection, the court shall set a hearing on the petition on an expedited basis.~~

~~(b) On a showing that notice would expose the child or either party to abuse as defined in § 4–501 of this article or for any other good cause the court shall waive the notice required by this section.~~

~~(c) If either party is required to relocate OR TRAVEL in less than the 90-day period specified in the notice requirement, the court may consider as a defense to any action brought for a violation of the notice requirement that:~~

~~(1) relocation OR TRAVEL was necessary due to financial or other
extenuating circumstances; and~~

~~(2) the required notice was given within a reasonable time after learning
of the necessity to relocate OR TRAVEL.~~

~~(d) The court may consider any violation of the notice requirement as a factor in
determining the merits of any subsequent proceeding involving custody or visitation.~~

(a) In this title the following words have the meanings indicated.

(d) (1) “Child custody determination” means a judgment, decree, or other order of a court providing for the legal custody, physical custody, or visitation with respect to a child.

(2) “Child custody determination” includes a permanent, temporary, initial, and modification order.

(3) “Child custody determination” does not include an order relating to child support or other monetary obligation of an individual.

(e) (1) “Child custody proceeding” means a proceeding in which legal custody, physical custody, or visitation with respect to a child is an issue.

(2) “Child custody proceeding” includes a proceeding for divorce, separation, neglect, abuse, dependency, guardianship, paternity, termination of parental rights, and protection from domestic violence, in which the issue may appear.

(3) “Child custody proceeding” does not include a proceeding involving juvenile delinquency, contractual emancipation, or enforcement under Subtitle 3 of this title.

(g) “Court” means an entity authorized under the law of a state to establish, enforce, or modify a child custody determination.

TITLE 9.7. MARYLAND CHILD ABDUCTION PREVENTION ACT.

(B) "ABDUCTION" MEANS: THE WRONGFUL REMOVAL OR WRONGFUL RETENTION OF A CHILD.

(C) "CHILD" MEANS AN INDIVIDUAL UNDER THE AGE OF 18 YEARS.

(D) "CHILD CUSTODY DETERMINATION" HAS THE MEANING STATED IN § 9.5-101 OF THIS ARTICLE.

(E) "CHILD CUSTODY PROCEEDING" HAS THE MEANING STATED IN § 9.5-101 OF THIS ARTICLE.

(F) "COURT" HAS THE MEANING STATED IN § 9.5-101 OF THIS ARTICLE.

(G) "PETITION" INCLUDES A MOTION OR ITS EQUIVALENT.

(H) "RECORD" MEANS INFORMATION THAT IS INSCRIBED ON A TANGIBLE MEDIUM OR THAT IS STORED IN AN ELECTRONIC OR OTHER MEDIUM AND IS RETRIEVABLE IN PERCEIVABLE FORM.

~~(H)~~(I) (1) "STATE" MEANS A STATE OF THE UNITED STATES, THE DISTRICT OF COLUMBIA, PUERTO RICO, THE U.S. VIRGIN ISLANDS, OR ANY TERRITORY OR INSULAR POSSESSION SUBJECT TO THE JURISDICTION OF THE UNITED STATES.

(2) "STATE" INCLUDES A FEDERALLY RECOGNIZED NATIVE AMERICAN NATION OR TRIBE.

(J) (1) "TRAVEL DOCUMENT" MEANS A RECORD RELATING TO A TRAVEL ITINERARY, INCLUDING A TRAVEL TICKET OR PASS OR A RESERVATION FOR TRANSPORTATION OR ACCOMMODATIONS.

(2) "TRAVEL DOCUMENT" DOES NOT INCLUDE A PASSPORT OR VISA.

(K) "WRONGFUL REMOVAL" MEANS A TAKING OF A CHILD THAT BREACHES RIGHTS OF CUSTODY OR VISITATION PROVIDED OR RECOGNIZED UNDER THE LAWS OF THE STATE.

(L) “WRONGFUL RETENTION” MEANS A KEEPING OR CONCEALING OF A CHILD THAT BREACHES RIGHTS OF CUSTODY OR VISITATION PROVIDED OR RECOGNIZED UNDER THE LAWS OF THE STATE.

8 ANOTHER STATE AS A PREREQUISITE TO ALLOWING THE CHILD TO TRAVEL TO THAT
9 STATE;

10 (4) WITH REGARD TO THE CHILD'S PASSPORT:

11 (I) A DIRECTION THAT THE PETITIONER PLACE THE CHILD'S
12 NAME IN THE UNITED STATES DEPARTMENT OF STATE'S CHILD PASSPORT
13 ISSUANCE ALERT PROGRAM;

14 (II) A REQUIREMENT THAT THE RESPONDENT SURRENDER TO
15 THE COURT OR THE PETITIONER'S ATTORNEY ANY UNITED STATES OR FOREIGN
16 PASSPORT ISSUED IN THE CHILD'S NAME, INCLUDING A PASSPORT ISSUED IN THE

7 (IV) A WRITTEN WAIVER UNDER THE FEDERAL PRIVACY ACT, 5
8 U.S.C. § 552A, WITH RESPECT TO ANY DOCUMENT, APPLICATION, OR OTHER
9 INFORMATION PERTAINING TO THE CHILD AUTHORIZING ITS DISCLOSURE TO THE
10 COURT AND THE PETITIONER; AND

11 (6) ON THE PETITIONER'S REQUEST, A REQUIREMENT THAT THE
12 RESPONDENT OBTAIN AN ORDER FROM THE RELEVANT FOREIGN COUNTRY
13 CONTAINING TERMS IDENTICAL TO THE CHILD CUSTODY DETERMINATION ISSUED
14 IN THE UNITED STATES.

15 (D) IN AN ABDUCTION PREVENTION ORDER THE COURT MAY IMPOSE
16 CONDITIONS ON THE EXERCISE OF CUSTODY OR VISITATION THAT:

17 (1) (I) LIMIT VISITATION OR REQUIRE THAT VISITATION WITH THE
18 CHILD BY THE RESPONDENT BE SUPERVISED UNTIL THE COURT FINDS THAT

(2) IF THE COURT FINDS THAT A LESS INTRUSIVE REMEDY WILL NOT BE EFFECTIVE, THE COURT MAY AUTHORIZE LAW ENFORCEMENT OFFICERS TO ENTER PRIVATE PROPERTY TO TAKE PHYSICAL CUSTODY OF THE CHILD.

(3) IF REQUIRED BY EXIGENT CIRCUMSTANCES, A COURT MAY AUTHORIZE LAW ENFORCEMENT OFFICERS TO MAKE A FORCIBLE ENTRY AT ANY HOUR.

(G) IF THE COURT FINDS, AFTER A HEARING, THAT A PETITIONER SOUGHT AN EX PARTE WARRANT UNDER SUBSECTION (A) OF THIS SECTION FOR THE PURPOSE OF HARASSMENT OR IN BAD FAITH, THE COURT MAY AWARD THE RESPONDENT REASONABLE ATTORNEY'S FEES, COSTS, AND EXPENSES.

(H) THIS TITLE DOES NOT AFFECT THE AVAILABILITY OF RELIEF IN OTHER PROVISIONS OF STATE LAW.
