## A BILL ENTITLED

1 AN ACT concerning

2 **Voting Rights Act of 2023 – Counties and Municipalities**

3 FOR the purpose of prohibiting local governments from impairing or diminishing the right  
4 of a protected class member to vote or influence election outcomes; establishing  
5 requirements on local governments regarding proposals for shifting methods of  
6 election and districting plans; requiring the Civil Rights Division of the Office of the  
7 Attorney General to approve or deny proposed local government remedies to address  
8 certain violations; establishing requirements on the State Board of Elections and  
9 local governments related to the provision of language-related assistance in local  
10 government elections; requiring the Civil Rights Division or the Circuit Court for  
11 Anne Arundel County to review and grant preclearance to certain policies before  
12 enactment or implementation; establishing the Statewide Election Database and  
13 Information Office to maintain and administer election-related data; prohibiting  
14 acts of intimidation or obstruction that interfere with the right to vote; and generally  
15 relating to voting rights in counties and municipalities.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

23 That the Laws of Maryland read as follows:

3           **(A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS**  
4 **INDICATED UNLESS A DIFFERENT MEANING IS CLEARLY INTENDED FROM THE**  
5 **CONTEXT.**

6           **(B) (1) “ALTERNATIVE METHOD OF ELECTION” MEANS A METHOD OF**  
7 **ELECTING CANDIDATES TO THE LEGISLATIVE BODY OF A LOCAL GOVERNMENT**  
8 **OTHER THAN AN AT-LARGE METHOD OF ELECTION OR A DISTRICT-BASED METHOD**  
9 **OF ELECTION.**

10           **(2) “ALTERNATIVE METHOD OF ELECTION” INCLUDES**  
11 **PROPORTIONAL RANKED-CHOICE VOTING, CUMULATIVE VOTING, AND LIMITED**  
12 **VOTING.**

13           **(C) (1) “AT-LARGE METHOD OF ELECTION” MEANS A METHOD OF**  
14 **ELECTING CANDIDATES TO THE LEGISLATIVE BODY OF A LOCAL GOVERNMENT IN**  
15 **WHICH THE CANDIDATES ARE VOTED ON BY ALL VOTERS OF THE LOCAL**  
16 **GOVERNMENT.**

17           **(2) “AT-LARGE METHOD OF ELECTION” DOES NOT INCLUDE ANY**  
18 **ALTERNATIVE METHOD OF ELECTION.**

19           **(D) “CIVIL RIGHTS DIVISION” MEANS THE CIVIL RIGHTS DIVISION OF THE**  
20 **OFFICE OF THE ATTORNEY GENERAL.**

21           **(E) “COURT” MEANS THE CIRCUIT COURT FOR ANNE ARUNDEL COUNTY.**

22           **(F) “DISTRICT-BASED METHOD OF ELECTION” MEANS A METHOD OF**  
23 **ELECTING CANDIDATES TO THE LEGISLATIVE BODY OF A LOCAL GOVERNMENT IN**  
24 **WHICH, FOR LOCAL GOVERNMENTS DIVIDED INTO DISTRICTS, A CANDIDATE FOR**  
25 **ANY DISTRICT IS REQUIRED TO RESIDE IN THE DISTRICT AND CANDIDATES**  
26 **REPRESENTING OR SEEKING TO REPRESENT THE DISTRICT ARE VOTED ON BY ONLY**  
27 **THE VOTERS OF THE DISTRICT.**

28           **(G) “FEDERAL VOTING RIGHTS ACT” MEANS THE FEDERAL VOTING**  
29 **RIGHTS ACT OF 1965.**

30           **(H) “LEGISLATIVE BODY” MEANS:**

31           **(1) FOR BALTIMORE CITY, THE CITY COUNCIL OF BALTIMORE CITY;**

1           **(2) FOR A CHARTER COUNTY, THE COUNTY COUNCIL;**

2           **(3) FOR A CODE HOME RULE COUNTY, THE COUNTY COMMISSIONERS;**

3           **(4) FOR A COMMISSION COUNTY, THE COUNTY COMMISSIONERS;**

4           **(5) FOR A MUNICIPALITY, THE REPRESENTATIVE BODY PROVIDED**  
5 **UNDER THE MUNICIPAL CHARTER; AND**

6           **(6) FOR A COUNTY BOARD OF EDUCATION, THE ELECTED VOTING**  
7 **MEMBERS OF THE COUNTY BOARD OF EDUCATION.**

8           **(I) “LOCAL GOVERNMENT” MEANS:**

9           **(1) A MUNICIPALITY OR COUNTY, AS THOSE TERMS ARE DEFINED IN §**  
10 **1–101 OF THE LOCAL GOVERNMENT ARTICLE; OR**

11           **(2) A COUNTY BOARD OF EDUCATION, AS DEFINED § 1–101 OF THE**  
12 **EDUCATION ARTICLE.**

13           **(J) “PROTECTED CLASS” MEANS A CLASS OF CITIZENS WHO ARE MEMBERS**  
14 **OF A RACE, COLOR, OR LANGUAGE MINORITY GROUP, AS REFERENCED IN THE**  
15 **FEDERAL VOTING RIGHTS ACT.**

16           **(K) “RACIALLY POLARIZED VOTING” MEANS VOTING IN WHICH THERE IS A**  
17 **DIVERGENCE BETWEEN THE CANDIDATE OR ELECTORAL CHOICE PREFERRED BY**  
18 **PROTECTED CLASS VOTERS AND THE CANDIDATE OR ELECTORAL CHOICE**  
19 **PREFERRED BY OTHER VOTERS.**

20           **(L) “VOTE” OR “VOTING” MEANS AN ACTION NECESSARY TO CAST A BALLOT**  
21 **IN AN ELECTION, INCLUDING:**

22           **(1) REGISTRATION;**

23           **(2) APPLYING FOR A BALLOT; AND**

24           **(3) ANY OTHER ACTION REQUIRED BY LAW AS A PREREQUISITE TO**  
25 **CASTING A BALLOT AND HAVING THE BALLOT COUNTED, CANVASSED, OR CERTIFIED**  
26 **PROPERLY AND INCLUDED IN THE APPROPRIATE TOTALS OF VOTES CAST IN AN**  
27 **ELECTION.**

1           **(A) THE PROVISIONS OF THIS TITLE APPLY TO A MUNICIPALITY IN THE**  
2 **STATE IN WHICH THE MUNICIPAL OR CHARTER ELECTIONS ARE REGULATED BY THE**  
3 **PUBLIC LOCAL LAWS OF THE STATE OR THE CHARTER OF THE MUNICIPALITY.**

4           **(B) STATUTES, RULES AND REGULATIONS, AND LOCAL LAWS, TOWN**  
5 **CHARTERS, OR ORDINANCES RELATED TO THE RIGHT TO VOTE SHALL BE**  
6 **CONSTRUED LIBERALLY IN FAVOR OF:**

7                   **(1) PROTECTING THE RIGHT TO CAST A BALLOT;**

8                   **(2) ENSURING THAT ELIGIBLE VOTERS ARE NOT IMPAIRED IN**  
9 **REGISTERING TO VOTE OR VOTING, INCLUDING HAVING THEIR VOTES COUNTED;**  
10 **AND**

11                   **(3) ENSURING PROTECTED CLASS VOTERS EQUITABLE ACCESS TO**  
12 **OPPORTUNITIES TO REGISTER TO VOTE AND TO VOTE.**

14           **IF ANY PROVISION OF THIS TITLE OR ITS APPLICATION TO ANY PERSON, LOCAL**  
15 **GOVERNMENT, OR CIRCUMSTANCE IS HELD TO BE INVALID BY A COURT OF**  
16 **COMPETENT JURISDICTION, THE INVALIDITY DOES NOT AFFECT OTHER PROVISIONS**  
17 **OR APPLICATIONS OF THIS TITLE THAT CAN BE GIVEN EFFECT WITHOUT THE**  
18 **INVALID PROVISION OR APPLICATION, AND TO THIS END, THE PROVISIONS OF THIS**  
19 **TITLE ARE SEVERABLE.**

20                           **SUBTITLE 2. PROTECTED CLASS MEMBERS.**

21 **15.5–201.**

22           **(A) A LOCAL GOVERNMENT MAY NOT DENY, IMPAIR, OR DIMINISH THE**  
23 **RIGHT TO VOTE OF PROTECTED CLASS MEMBERS THROUGH ANY:**

24                   **(1) QUALIFICATION FOR ELIGIBILITY TO BE A VOTER OR OTHER**  
25 **PREREQUISITE TO VOTING; OR**

26                   **(2) ORDINANCE, REGULATION, OR OTHER LAW REGARDING THE**  
27 **ADMINISTRATION OF ELECTIONS, OR ANY STANDARD, PRACTICE, PROCEDURE, OR**  
28 **POLICY.**

29           **(B) THE FOLLOWING ACTIONS BY A LOCAL GOVERNMENT SHALL**  
30 **CONSTITUTE A VIOLATION OF SUBSECTION (A) OF THIS SECTION:**

1           **(1) IMPLEMENTATION OF A QUALIFICATION FOR ELIGIBILITY TO BE A**  
2 **VOTER OR OTHER PREREQUISITE TO VOTING, OR AN ORDINANCE, REGULATION, OR**  
3 **OTHER LAW REGARDING THE ADMINISTRATION OF ELECTIONS, OR ANY STANDARD,**  
4 **PRACTICE, PROCEDURE, OR POLICY THAT:**

5           **(I) RESULTS OR WILL RESULT IN ANY DISPARITY OR**  
6 **REDUCTION IN VOTER PARTICIPATION, ACCESS TO VOTING OPPORTUNITIES, OR**  
7 **ABILITY TO PARTICIPATE IN THE POLITICAL PROCESS AMONG PROTECTED CLASS**  
8 **MEMBERS IN A JURISDICTION; OR**

9           **(II) BASED ON THE TOTALITY OF THE CIRCUMSTANCES,**  
10 **RESULTS IN ANY IMPAIRMENT OF THE OPPORTUNITY OR ABILITY OF PROTECTED**  
11 **CLASS MEMBERS TO PARTICIPATE IN THE POLITICAL PROCESS AND ELECT**  
12 **CANDIDATES OF THEIR CHOICE OR OTHERWISE INFLUENCE THE OUTCOME OF**  
13 **ELECTIONS; OR**

14           **(2) ENACTMENT OF A QUALIFICATION FOR ELIGIBILITY TO BE A**  
15 **VOTER OR OTHER PREREQUISITE TO VOTING, OR AN ORDINANCE, REGULATION, OR**  
16 **OTHER LAW REGARDING THE ADMINISTRATION OF ELECTIONS, OR ANY STANDARD,**  
17 **PRACTICE, PROCEDURE, OR POLICY THAT HAS THE PURPOSE OF, OR WILL HAVE THE**  
18 **EFFECT OF, DIMINISHING THE ABILITY OF ANY PROTECTED CLASS VOTER TO**  
19 **PARTICIPATE IN THE ELECTORAL PROCESS OR ELECT THE PREFERRED CANDIDATES**  
20 **OF CHOICE OF THE PROTECTED CLASS VOTER.**

21 **15.5-202.**

22           **(A) A LOCAL GOVERNMENT MAY NOT EMPLOY ANY METHOD OF ELECTION**  
23 **THAT HAS THE EFFECT, OR IS MOTIVATED IN PART BY THE INTENT, OF IMPAIRING**  
24 **THE ABILITY OF PROTECTED CLASS MEMBERS TO PARTICIPATE IN THE POLITICAL**  
25 **PROCESS AND ELECT CANDIDATES OF THEIR CHOICE OR OTHERWISE INFLUENCE**  
26 **THE OUTCOME OF ELECTIONS, AS A RESULT OF DILUTING OR ABRIDGING THE VOTE**  
27 **OF THE PROTECTED CLASS MEMBERS.**

28           **(B) IMPLEMENTATION OF THE FOLLOWING ELECTION METHODS BY A LOCAL**  
29 **GOVERNMENT SHALL CONSTITUTE A VIOLATION OF SUBSECTION (A) OF THIS**  
30 **SECTION:**

31           **(1) AN AT-LARGE METHOD OF ELECTION WHERE:**

32           **(I) RACIALLY POLARIZED VOTING BY PROTECTED CLASS**  
33 **VOTERS OCCURS; OR**

1           **(II) BASED ON THE TOTALITY OF THE CIRCUMSTANCES, THE**  
2 **OPPORTUNITY OR ABILITY OF PROTECTED CLASS VOTERS TO PARTICIPATE IN THE**  
3 **POLITICAL PROCESS AND ELECT CANDIDATES OF THEIR CHOICE OR OTHERWISE**  
4 **INFLUENCE THE OUTCOME OF ELECTIONS IS IMPAIRED;**

5           **(2) A DISTRICT-BASED METHOD OF ELECTION OR AN ALTERNATIVE**  
6 **METHOD OF ELECTION WHERE THE CANDIDATES OR ELECTORAL CHOICES**  
7 **PREFERRED BY PROTECTED CLASS MEMBERS WOULD USUALLY BE DEFEATED AND**  
8 **WHERE:**

9           **(I) RACIALLY POLARIZED VOTING BY PROTECTED CLASS**  
10 **VOTERS OCCURS; OR**

11           **(II) BASED ON THE TOTALITY OF THE CIRCUMSTANCES, THE**  
12 **ABILITY OF THE VOTERS TO PARTICIPATE IN THE POLITICAL PROCESS AND ELECT**  
13 **CANDIDATES OF THEIR CHOICE OR OTHERWISE INFLUENCE THE OUTCOME OF**  
14 **ELECTIONS IS IMPAIRED; OR**

15           **(3) ANY METHOD OF ELECTION THAT HAS THE PURPOSE OF, OR WILL**  
16 **HAVE THE EFFECT OF, DIMINISHING THE ABILITY OF ANY PROTECTED CLASS VOTER**  
17 **TO PARTICIPATE IN THE ELECTORAL PROCESS OR ELECT THE PREFERRED**  
18 **CANDIDATES OF CHOICE OF THE PROTECTED CLASS VOTER.**

19           **(C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, TO**  
20 **DETERMINE WHETHER RACIALLY POLARIZED VOTING BY PROTECTED CLASS**  
21 **VOTERS IN A LOCAL GOVERNMENT ELECTION OCCURS OR IF CANDIDATES OR**  
22 **ELECTORAL CHOICES PREFERRED BY PROTECTED CLASS MEMBERS WOULD**  
23 **USUALLY BE DEFEATED, THE CIRCUIT COURT FOR ANNE ARUNDEL COUNTY SHALL:**

24           **(I) CONSIDER ELECTIONS HELD BEFORE THE FILING OF AN**  
25 **ACTION AS MORE PROBATIVE THAN ELECTIONS CONDUCTED AFTER THE FILING;**

26           **(II) CONSIDER EVIDENCE CONCERNING ELECTIONS FOR ANY**  
27 **OFFICE IN THE LOCAL GOVERNMENT, INCLUDING EXECUTIVE, LEGISLATIVE,**  
28 **JUDICIAL, AND OTHER OFFICES OF THE LOCAL GOVERNMENT, AS MORE PROBATIVE**  
29 **THAN EVIDENCE CONCERNING ELECTIONS FOR OTHER OFFICES;**

30           **(III) CONSIDER STATISTICAL EVIDENCE AS MORE PROBATIVE**  
31 **THAN NONSTATISTICAL EVIDENCE; AND**

32           **(IV) IN THE CASE OF CLAIMS BROUGHT ON BEHALF OF TWO OR**  
33 **MORE PROTECTED CLASSES THAT ARE POLITICALLY COHESIVE WITHIN THE**  
34 **ELECTION DISTRICT OF THE LOCAL GOVERNMENT, COMBINE VOTERS OF THE**

1 PROTECTED CLASSES TO DETERMINE WHETHER VOTING BY MEMBERS OF THE  
2 COMBINED PROTECTED CLASSES IS POLARIZED FROM OTHER VOTERS AND WITHOUT  
3 REQUIRING EVIDENCE THAT EACH PROTECTED CLASS IS SEPARATELY POLARIZED  
4 FROM OTHER VOTERS.

5 (2) IN DETERMINING WHETHER RACIALLY POLARIZED VOTING BY  
6 PROTECTED CLASS VOTERS IN A LOCAL GOVERNMENT ELECTION OCCURS, THE  
7 CIRCUIT COURT FOR ANNE ARUNDEL COUNTY MAY NOT:

8 (I) REQUIRE EVIDENCE CONCERNING THE INTENT OF VOTERS,  
9 ELECTED OFFICIALS, OR THE LOCAL GOVERNMENT TO DISCRIMINATE AGAINST  
10 PROTECTED CLASS VOTERS;

11 (II) REQUIRE EVIDENCE OF EXPLANATIONS FOR VOTING  
12 PATTERNS AND ELECTION OUTCOMES TO PROVE THE EXISTENCE OF RACIALLY  
13 POLARIZED VOTING, INCLUDING PARTISANSHIP;

14 (III) CONSIDER EVIDENCE THAT SUBGROUPS OF PROTECTED  
15 CLASS ELECTORS HAVE DIFFERENT VOTING PATTERNS;

16 (IV) CONSIDER EVIDENCE CONCERNING WHETHER PROTECTED  
17 CLASS VOTERS ARE GEOGRAPHICALLY COMPACT OR CONCENTRATED, BUT MAY USE  
18 THE EVIDENCE TO APPROPRIATELY REMEDY A VIOLATION UNDER THIS SECTION; OR

19 (V) CONSIDER EVIDENCE CONCERNING PROJECTED CHANGES  
20 IN POPULATION OR DEMOGRAPHICS, BUT MAY USE THE EVIDENCE TO  
21 APPROPRIATELY REMEDY A VIOLATION UNDER THIS SECTION.

23 (A) (1) IN DETERMINING WHETHER, BASED ON THE TOTALITY OF THE  
24 CIRCUMSTANCES, A DENIAL OR IMPAIRMENT OF THE RIGHT TO VOTE FOR ANY  
25 PROTECTED CLASS HAS OCCURRED, OR THE OPPORTUNITY OR ABILITY OF  
26 PROTECTED CLASS MEMBERS TO PARTICIPATE IN THE POLITICAL PROCESS AND  
27 ELECT CANDIDATES OF THEIR CHOICE OR OTHERWISE INFLUENCE THE OUTCOME  
28 OF ELECTIONS IS IMPAIRED, THE CIRCUIT COURT FOR ANNE ARUNDEL COUNTY  
29 MAY CONSIDER THE FOLLOWING FACTORS:

30 (I) THE HISTORY OF DISCRIMINATION IN OR AFFECTING THE  
31 STATE OR LOCAL GOVERNMENT;

32 (II) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE  
33 EXTENT TO WHICH PROTECTED CLASS VOTERS HAVE BEEN ELECTED TO OFFICE IN

1 THE LOCAL GOVERNMENT;

2 (III) THE USE OF ANY QUALIFICATION FOR ELIGIBILITY TO BE A  
3 VOTER OR OTHER PREREQUISITE TO VOTING, OR ANY STATUTE, ORDINANCE,  
4 REGULATION, OR OTHER LAW REGARDING THE ADMINISTRATION OF ELECTIONS, OR  
5 ANY RELATED STANDARD, PRACTICE, PROCEDURE, OR POLICY BY THE LOCAL  
6 GOVERNMENT THAT MAY ENHANCE THE DILUTIVE EFFECTS OF A METHOD OF  
7 ELECTION IN THE LOCAL GOVERNMENT;

8 (IV) THE DENIAL OF ACCESS OF PROTECTED CLASS VOTERS OR  
9 CANDIDATES TO ELECTION ADMINISTRATION OR CAMPAIGN FINANCE PROCESSES  
10 THAT DETERMINE WHICH CANDIDATES WILL RECEIVE ACCESS TO THE BALLOT OR  
11 FINANCIAL OR OTHER SUPPORT IN A GIVEN ELECTION IN THE LOCAL GOVERNMENT;

12 (V) THE EXTENT TO WHICH PROTECTED CLASS INDIVIDUALS IN  
13 THE STATE OR THE LOCAL GOVERNMENT CONTRIBUTE MONEY TO POLITICAL  
14 CAMPAIGNS OR POLITICAL CAUSES AT LOWER RATES THAN OTHER INDIVIDUALS IN  
15 THE STATE OR THE LOCAL GOVERNMENT;

16 (VI) THE EXTENT TO WHICH PROTECTED CLASS VOTERS IN THE  
17 STATE OR THE LOCAL GOVERNMENT VOTE AT LOWER RATES THAN OTHER VOTERS  
18 IN THE STATE OR THE LOCAL GOVERNMENT, AS APPLICABLE;

19 (VII) THE EXTENT TO WHICH PROTECTED CLASS INDIVIDUALS IN  
20 THE LOCAL GOVERNMENT BEAR THE EFFECTS OF DISCRIMINATION, PUBLIC OR  
21 PRIVATE, IN AREAS SUCH AS EDUCATION, EMPLOYMENT, HEALTH, CRIMINAL  
22 JUSTICE, HOUSING, TRANSPORTATION, LAND USE, OR ENVIRONMENTAL  
23 PROTECTION;

24 (VIII) THE EXTENT TO WHICH PROTECTED CLASS INDIVIDUALS IN  
25 THE LOCAL GOVERNMENT ARE DISADVANTAGED IN OTHER AREAS THAT MAY  
26 HINDER THEIR ABILITY TO PARTICIPATE EFFECTIVELY IN THE POLITICAL PROCESS;

27 (IX) THE USE OF OVERT OR SUBTLE RACIAL APPEALS IN  
28 POLITICAL CAMPAIGNS IN THE LOCAL GOVERNMENT OR SURROUNDING ADOPTION  
29 OR MAINTENANCE OF THE CHALLENGED PRACTICE;

30 (X) THE EXTENT TO WHICH CANDIDATES FACE HOSTILITY OR  
31 BARRIERS ON ACCOUNT OF THEIR MEMBERSHIP IN A PROTECTED CLASS WHILE  
32 CAMPAIGNING;

33 (XI) A LACK OF RESPONSIVENESS BY ELECTED OFFICIALS OF  
34 THE LOCAL GOVERNMENT TO THE PARTICULARIZED NEEDS OF PROTECTED CLASS



1 INDIVIDUALS, INCLUDING A LACK OF CONCERN FOR, OR RESPONSIVENESS TO, THE  
2 REQUESTS AND PROPOSALS OF THE GROUP, WITHOUT CONSIDERING COMPLIANCE  
3 WITH A COURT ORDER AS EVIDENCE OF RESPONSIVENESS ON THE PART OF THE  
4 JURISDICTION;

5 (XII) WHETHER THE PARTICULAR METHOD OF ELECTION,  
6 ORDINANCE, REGULATION, OR OTHER LAW, OR RELATED STANDARD, PRACTICE,  
7 PROCEDURE, OR POLICY WAS DESIGNED TO ADVANCE AND MATERIALLY ADVANCES  
8 A VALID AND SUBSTANTIATED STATE INTEREST; AND

9 (XIII) OTHER FACTORS AS THE COURT MAY DETERMINE TO BE  
10 RELEVANT.

11 (2) FOR THE PURPOSE OF CONSIDERING THE FACTOR LISTED IN  
12 PARAGRAPH (1)(II) OF THIS SUBSECTION, IF A MINORITY GROUP IS TOO SMALL TO  
13 ELECT CANDIDATES OF ITS CHOICE, THAT FACT ALONE MAY NOT DEFEAT A CLAIM  
14 OF VOTE DENIAL OR ABRIDGMENT.
