AMENDMENTS TO HOUSE BILL 978
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegates Stein, Guyton, Allen, Ebersole, Forbes, McCaskill, Pasteur, Phillips, Ruth, and White Holland**” and substitute “**Baltimore County Delegation**”; and in line 7, after “to” insert “recover costs and”.

AMENDMENT NO. 2

On page 2, in line 13, strike “ASSIST” and substitute “:

**A. RECOVER THE COST OF IMPLEMENTING AND
ADMINISTERING THE SPEED MONITORING SYSTEMS ON INTERSTATE 695 AND
INTERSTATE 83 IN BALTIMORE COUNTY; AND**

B. ASSIST”.

On page 4, in lines 8 and 18, in each instance, after “(II)” insert “1.”; strike beginning with the first comma in line 11 down through “DEPARTMENT” in line 12; after lines 13 and 23, in each instance, insert:

**“2. A SPEED MONITORING SYSTEM SPECIFIED IN
SUBPARAGRAPH (I) OF THIS PARAGRAPH MAY NOT BE PLACED WITHIN 5 MILES
OF ANOTHER SPEED MONITORING SYSTEM OPERATING IN THE SAME
DIRECTION.”;**

strike beginning with the first comma in line 21 down through “DEPARTMENT” in line 22; in line 24, after “(3)” insert “(I)”; in the same line, after “(1)” insert “OR (2)”; strike

in their entirety lines 26 and 27; in line 28, strike “(II)”; and in line 30, after “INCLUDE” insert “CONSPICUOUS”.

On page 5, after line 4, insert:

“(II) A SPEED MONITORING SYSTEM OPERATOR NEED NOT BE PRESENT IN PERSON OR REMOTELY AT THE HIGHWAY CORRIDOR WHERE A SPEED MONITORING SYSTEM IS IN USE.”.

On page 7, in line 30, strike “90” and substitute “30”.

On page 10, after line 32, insert:

“SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 1 in calendar years 2026 through 2028, the State Highway Administration shall report to the members of the Baltimore County Delegation to the General Assembly, in accordance with § 2-1257 of the State Government Article, on the revenue collected and distributed by the State Highway Administration from the speed monitoring systems authorized under § 21-811 of the Transportation Article, as enacted by Section 1 of this Act.”.

On page 11, in line 1, strike “2.” and substitute “3.”.
