16 17 18	WHEREAS, Thomas V. Mike Miller, Jr., was the longest serving State Senate President in America's history, having served as Maryland Senate President from 1987 to 2020 during his 49 years of service in the General Assembly; and
19 20	WHEREAS, Thomas V. Mike Miller, Jr., worked in a bipartisan manner to pass meaningful legislation; and

Mike Miller, Jr., had a passion for the Chesapeake Bay and for education, and was active with the Chesapeake Bay Trust family since 1985 when it was established by the Maryland General Assembly to engage people in the protection and restoration of natural resources; and
